## Event Application Review, Selection and Guidelines

- Applications for Non-CME activities must be submitted by June 25, 2010. Requested times will be honored as space and topic permit on a "first-received, first-assigned" basis. Applications will be reviewed by the Florida Obstetric and Gynecologic Society (FOGS) to ensure compliance with guidelines.
- Event artwork, faculty selection and Program Title/Description must be submitted to the FOGS by July 2, 2010, for approval by the FOGS.
- Faculty for such events may not include FOGS Board Member and Sessions Faculty.
- Events selected shall only be held in space released by FOGS at times that do not conflict with the official sessions sponsored by the FOGS.
- Sleeping rooms must be reserved under the contracted room block set up by the FOGS.
- Receipt of complete applications will be confirmed by e-mail. Applications will be reviewed within a two-week timeframe. Notification of acceptance (or required changes) will be e-mailed no later than one month prior to the start date of the Pathways to Excellence meeting.
- FOGS, at its sole discretion, reserves the right to refuse selection if all slots are filled, the program is non-compliant with our standards, or the event does not meet the needs of the audience of FOGS. If an application is not accepted, the organizer and supporter shall be notified as soon as possible. It is the responsibility of the organizer to cancel any arrangements that might have been made in connection with the symposium. FOGS will not be responsible for any expenditure or other costs incurred by the supporter or its agent(s) in planning or conducting the symposium.
